**RE** – Chuck Heretta noted the proceeds from Mound City will be donated to the region. Noted that Corvette Cle will have their Corsa on July 28. This is a non-sanctioned event. Chuck says the fees are due on Jan 15. There was discussion about mileage limits; there must be 100 miles separation.

**Hall of Fame** – Al Etzel – Nominations opened in July and close in December. There is one nomination at this point. The nominee is Carol Engler. The HOF needs the forms sent to Al by the end of Feb to allow time for the Region meeting to review it.

**Membership** – Peggy Stephens sent out the information to all governors that will be presented today. We have 911 members, 81 less members than in Oct. There were 858 members at the end of 2011. We have ended 2012 with 53 more members than 2011. We surpassed her 2012 goal by 32 members. She thanked each of the clubs for their hard work in getting new members and hopes that we can go our goals in 2013. She reviewed the membership reports with the attendees present today. Total of 273 clubs in the country today. See Peggy's reports attached for details of membership. Peggy needs FCOA forms to her before 14 of Dec. Any other membership forms also need to be in by that date.

#### **NEW BUSINESS-**

Banquet bids for 2014 in the works.

Balloting is done for the proposed amendments. All failed. A copy of the ballot is attached to this report.

There was discussion about the amendments. As to why they came about and such. The reasons were explained, rebutted, and the discussion ended. In conclusion the **all amendments failed** due to a majority no vote. The subject is now closed.

Next Nat'l meeting is Feb 22-24 in St. Louis. The Region meeting will start at 10am with exception of the banquet meeting which will start at 930 am.

Street series proposals will be gone over at the region meeting in Mar.

A (2 each) rally is proposed for southern Ohio this year. Chuck Stevens asked for permission to be reimbursed for expenses to come to do this rally if they materialize since it would be a regional event. A vote was taken and **the vote passed**.

The scholarship fund, (Gene Coody fund, spelling is suspect here), this is a standing rule proposal. The fund will accumulate at a rate of 750.00 per year to a max of 2250.00. The region has agreed that the fund will have donations of at least 750.00 per year, building to a max of 1500.00, 750.00 will be donated to NCCC fund each year. The motion to change the rule passed.

Timing equipment, a reimbursement cost for transporting and maintenance of the trailer with the equipment for 55 cents per mile was proposed. These 55 cents is allowed by the IRS. The motion was proposed; a vote was taken and passed. Region pays for upkeep and maintenance of the equipment. This also passed.

**WEBMASTER** - Tim Obert, he did a web cast of today's meeting. This once the bugs are worked out will be available on the EOR website. Also the audio recording of today's meeting will also be available on the website if needed. The Region secretary has a copy of the audio.
