The meeting was called to order at 10:09 am by Regional Executive Terry Sells.

The meeting opened with the Pledge of Allegiance led by Chuck Stephens.

RE Terry Sells acknowledged Chicken Manor is closing. The meeting location for 2015 will be Belgrade in Akron. The only difference would be the starting time. Belgrade opens at 11:00. Contact Terry if you have any other locations to consider.

The first order of business was the confirmation of the minutes from the October, 2014 meeting. No corrections noted. Terry Sells requested a motion to accept the minutes as published. Terry Muich made a motion to accept and a second was made by Ron Sommer. The motion passed.

The next order of business was the treasurer's report presented by Ana Phillips who was appointed by RE Sells to replace Dan Lyden. Ana indicated that she had not received the check book or bank statements prior to the meeting so she contacted the automated bank line to obtain the checking account balance and a listing of debits and credits since the last meeting. The report was based on that information. Ana advised that she is in the process of balancing the account for the past year. Copies of the treasurer's report were available for attendees. Additionally, Ana advised that anyone seeking reimbursement will need to fill out a reimbursement request. Mickey Ouellette asked if the account will be broken out into individual funds such as the Kuty Scholarship Fund. Ana will sort through prior documents and statements to find the current balance in each fund. Terry Muich indicated that Ana must be confirmed as Treasurer. A vote was taken and the appointment passed. Alan Moore requested an audit be completed. It was agreed that Roger Flading, along with assistance from several governors, will conduct an audit once Ana has a chance to organize any information obtained from the prior treasurer. Terry requested a motion to accept the treasurer's report as written. Terry Muich made a motion to accept and a second was made by Bruce Warnick. The motion passed.

In Peggy's absence, Chuck Stephens, provided the membership report. Chuck summarized East Ohio Region's most recent membership data. Additionally, NCCC's membership status was discussed. Handouts outlining the data were distributed to all attendees. NCCC Officers for 2015 are: Dave Heineman – President, Steve Johnson – Vice President, Betty Parks – Treasurer, James Walter – Parliamentarian, and Denny Luther – Director of Publication. The membership database will go down December 10th. Anyone who signs up after that date will be either new or late renewal.

Chuck Stephens, Regional Competition Director, presented a summary of the rule book changes. A copy of the entire rule book is available on line. Please review and note the changes. A handbook will be issued for the database.

RE Terry Sells discussed the meeting in St Louis. Dave Heineman suggested changes to how charity work is done nationally. His suggestion is to keep the winner of the Corvette within the NCCC family. He wants to raise the dues to cover the cost of the car along with raising \$100,000. A straw vote was taken and everyone was against the format change. Terry will vote against the proposal at the next national meeting.
