The meeting was called to order at 9:30 am by Regional Executive Terry Muich. The meeting opened with the Pledge of Allegiance led by Chuck Stephens

All Clubs are represented – a quorum with 13 Governors.

The 2023 Board was introduced.

<u>Secretary (Karen Santagata via Terry Muich)</u> – Minutes of the March 2nd meeting were emailed to all Governors prior to the meeting. No corrections were made. Sharon Burk made a motion to suspend the reading of the minutes and to accept the Minutes as emailed, motion seconded by Chuck Stephens. Motion passed.

Regional Membership Director (Cheryl Getzy) - Cheryl thanked the Governors for all of their hard work to

get everything entered on time. All payments have been received. She reiterated information on late memberships which is \$5 more.

17,186 members as of NCCC Meeting.

FCOA is still growing and Shannon Davis is still overseeing the program.

Cheryl did mention about checking an application to see if the person(s) are in the database. Governors should look up members to ensure that they are renewing or new members. Be careful to include an Ohio address. Do not forget to have new members fill out a NCCC membership form.

<u>Treasurer and Finance (Sue Hamilton)</u> – Everyone received a Treasurer's report and Finance Report that Sue put on every table. Sue discussed the annual year which begins December 1 and we are currently in the first quarter. Reminder that "timing" is part of "competition." Track X payments are starting to come in.

Dave Brennan made a motion to accept the Treasurer's Report, seconded by Barb Kukasky. The motion passed.

Terry provided an update on Gus Santagata's Covid health issues and that Karen is exhausted. (From Karen: Thank you everyone!!!!!!)

At this time, the Governors introduced themselves and then guests introduced themselves

<u>Regional Competition Director (Dan Gallagher via Terry Muich)</u> – Prior to this meeting, Dan emailed his report which is attached to this report and reviewed some highlights so that the Governors who do not attend the NCCC meeting are made aware of what was discussed. No questions from Governors.

Peggy Quine asked if Dan could make the font bigger on the checklist for competition form. Some of the Governors stated that Dan sent it in Word format to alleviate the small font problem. Remember if you do not get a timely response, you can contact Terry.

Bob Niznick asked for a clarification concerning awards relating to a non-NCCC attendees versus a NCCC member at car shows. Terry explained that Governors need to follow the number of awards that are covered by NCCC Rules for NCCC members. It is the discretion of the Host Club on what awards to give to non-NCCC attendees. The voting is also detailed in the NCCC Rules and lists who gets ballots. Terry went into more detail about voting procedures.

Chuck Stephens made a motion to accept the Regional Competition Director's report as emailed, seconded by Bill Ambuter. The motion passed.

Hall of Fame Committee Report (Mickey Ouellette) – Terry brought up that Bob Kuty asked about the hard copy book of Hall of Fame. Apparently, Al Flanhofer and Warren Obert were going to update it which Al confirmed. Al was tasked o email the PDF and Word copy to Terry and Mickey. Al did not update the book because he is not on the Hall of Fame Committee any longer. Terry mentioned that we are all in the Region and should do what we can to make everything successful. Terry will continue to follow up with Al to get the book.

Mickey stated that there are no inductees for this year, but the three inductees for 2021 would receive their plaques - Sue Hamilton, Peggy Stephens and Chuck Stephens. There was a discussion of the committee about the change to ³/₄ of Clubs needed to be more than 9.7 and rounded up would be 10 votes – super majority vote must be 10 votes. Mickey gave a short history of past experiences. Terry stated that participation is key, including during the voting process.

Bob Niznick made a motion to accept the Hall of Fame's report, seconded by Chuck Stephens. The motion passed. Questions or suggestions can be presented at any time to the Committees.

Banquet Committee (Sue Hamilton) – Sue thanked everyone who signed up – it's nice to have a banquet again. Breakfast is included for those who are staying at the hotel. A program is planned for the event. No speaker this year – a ventriloquist. Terry thanked Barb and Sue for all their hard work and making the banquet happen this year. Sue thanked Buckeye Corvettes for hosting the banquet and thanked everyone who helped. Terry asked if there was a club that would want to step for next years banquet. This is something that should be done by a club – not the Region. There is nothing in the Rules that states there must be a banquet. Sharon asked why a club has to host it and not the Committee. Terry asked why the committee members need to do all the work. If a club is hosting it, then perhaps that club will have more members in attendance. There is a lot of apathy going on right now – even at the national level. Barb said it could be two clubs. Any changes can be done via a rule change. Sue also thanked the Hall of Fame Committee that agreed to pay for the cakes at the Banquet.

By-Laws and Standing Rules (Terry Muich) -

Committee consists of Terry Much, Mickey Oulette, Chuck Stephens and Bill Ambuter.

1. <u>Standing Rule – Competition (No number indicated on submission)</u> Previously voted on in September 2022 to take effect in 2023, which stated: "Any member of a host club at a people's choice car show cannot vote for fellow members or applicants cars. At any people's choice care show a participating club cannot vote for club members or applicants car."

After further review, the above was found to be in violation of NCCC Rules. John Baron did research and found in NCCC Rules:

7.9. PEOPLE'S CHOICE CONCOURS In a People's Choice Concours, the Corvettes are separated into Classes chosen by the Host Club. Entrants and spectators then vote for their favorite car in each Class.

This only relates to trophies – everyone gets the same points. <u>The Governors voted unanimously voted to</u> suspend the above Standing Rule.

A Standing Rule can be voted on with a super majority when it is presented. The recommendation is to present it and then table it for further review to make sure no issues come up.

2. The following Standing Rules that were presented at the EOR December 2022 meeting are being withdrawn.

<u>2022-001 Section 11, Competition</u> – No East Ohio Points will be awarded to members of clubs for East Ohio Region Sanctioned events held outside of the East Ohio Region Boundaries. (National Points will be awarded).

There was nothing found about where sanctions can be put on. The rules simply state NCCC awards the sanctions to the clubs. It states that to get sanction points you get points for attending sanctioned events in your region. All region points apply to national points, but not all national points apply to region points. If you attend an event out of region, you get national points, but you do not regional points. If anyone wants to follow up on this, then someone may want to submit a change at the national level. This also involves the snow birds – as long as a member stays at least 6 months at a primary address, then travel points are awarded based on that address. It has changed over the years – multiple variations including zip code of club, then it involved 50 to 100 miles.

<u>2022-002 Section 12, Competition</u> –*No East Ohio Region club member shall be awarded travel points for event held with the East Ohio Region (National Points will be awarded).*

After further review, the above were found to be in violation of *NCCC Rule 8 Championship Points.* "....The number and type of points earned will be dependent on whether the event is sanctioned by the entrant's Region, the entrant's Club, the entrant's finishing position, and the distance traveled to the event."

2022-003 Section 13, Competition (REGION ONLY)

An East Ohio Region Club will lose its place in the bidding of sanctions if they give or sell, all their sanctions away. (When a club gives all their sanctions away it give the club receiving them an extra turn in each round of sanction picks. This is an unfair advantage to those clubs and goes against the bidding order.)

An argument also relating to this when clubs go together and by making this rule this will prevent a club from getting a pick in the bidding. This was authored by Dan Gallagher and was tabled at the December 2022 meeting and a simple majority is needed to pass it at this time.

Mickey mentioned that her Club is the only Club affected by this change. Mickey asked for clarification because her Club is already in last place. Terry explained that this would only apply to the first two rounds of the bidding. It will not affect the third round or anything further. If sanctions were given to another Club, then the receiving Club would ultimately have more picks in the bidding process. Mickey stated that we are trying to be a better region and to pick on one club it is not fair to which Terry stated we are not picking on any club. Terry discussed different scenarios with NEOVC and EOR receiving their sanctions. Chuck S. spoke up that Kanawha and CCA were very transparent with their selection of dates. And communication with Mound City (Dave B.) worked through issues. Dave B. mentioned the flyer issue but the RCD or a member of the Club has to be present for those to receive points. Terry believes that this Rule change would just make things out in the open. Terry talked about the process that Dan did for 2023 events and the email communications between clubs and how everyone worked together to resolve any issues. Chuck S. mentioned that it is speed events that are affected and the cost, no venues and participation are affected. In addition, Chuck said that volunteers are getting older. Clubs need to work together instead of separating clubs. Terry said that not every NCCC region does it the same way.

Chuck H. stated that the 3 Rule changes were tabled at the December 2022. He stated that in order to vote on this change separately, there must a motion made to bring it off the table. If that motion passes, then it can be voted on. <u>Chuck S. made a motion to bring this change off "tabled" and it was seconded by Bob N. Motion passed.</u> Terry re-opened the discussion. <u>Chuck S. made a motion to vote on the Change and it was seconded by Bob N. Motion passed</u>. A vote was taken for **2022-003 regarding pick order for sanctions bidding**. (3 – 10 was the vote). <u>The Rule Change failed</u>.

4. <u>2023-001 – Standing Rule (Attached for full details)</u>

FCOA members are awarded points on regional level. (Children under age of 18)

for attendance at sanctioned event
for assisting at sanctioned event
for NCCC member/sponsor car placing at sanctioned event
RCD appoints person to collect points and tabulate
Top 5 get award at end of year not to exceed \$150 total
Region pays for awards
NCCC parent waiver must be signed at registration

Authored by Bill Ambuter. This only applies to Regional points. FCOA members are awarded points on the Regional level. Bill then discussed his objectives of this Standing Rule. A form will be made, so that the Governors will fill out a form. Jackie S (Corvette Cleveland). has agreed to do it for the first year. After that the RCD will appoint someone else. The top 5 FCOA active members will receive an award – limiting the awards to \$150. Bill then reviewed the NCCC Rules that "encourages future participation" (see Section 2.2.7)

<u>Fun Buck Runs and Section 2.2.8 Passengers</u> – added for reference). Bill then reviewed the age limitations for each type of event per NCCC Rules. All FCOA members must comply with the parental waive form that all clubs should be using already. Peggy Q. asked about adding something on the registration form, to which Bill stated that it would not be necessary. Bill's suggestion would be to populate a form with the number of points that each FCOA member would receive. Bob again reiterated that we need to encourage future participation by younger FCOA members.

Cheryl G. stated the age of 16 being the oldest FCOA member. The numbers of FCOA members has not been kept up by NCCC - EOR has approximately 150 FCOA members. Bob N. mentioned that FCOA members over 9 or 10 years will benefit – not for his granddaughter at 3 years old. Mickey O. stated the Rule Change is a good idea but it needs to be clarified. A minimum age needs to be added for clarification. Bill said that age is not an issue. Terry and Mickey agreed that it needs have clarification. Chuck S. commented on the attendance at what events and more clarification -- it's too open for discrepancy. Terry's suggestion to Bill was for him to read the change into the minutes, and that it be tabled for further discussion and clarification. Taking a little extra time, it's a better way. Mickey asked about the awards being given at banquet and the venue with the serving of alcohol. Bob N. wanted clarification about voting for this Rule and when it would take effect – perhaps next year would be beneficial. If voted in now, it would be in affect for 2023. Peggy Q. said it needs more detail. Bill doesn't understand why there needs to be more clarification – it's important to get this going. John B. asked why if it gets started in May v. April it's not the end of the world. Peggy S. stated that it has to have an age verification - not for a 2-day old baby to get a point. Governors seem to think it's a great idea, but the common comments are that more clarifications are needed. Dave B. questioned about a 9-year old for navigator for a rallye. Bob N. agrees that we need more clarifications – we're all adults and need to be responsible. Chuck S. likes the idea but has concerns about Jackie S. doing the points – Bill said an updated form was given out. It was changed to the RCD, not an individual. Terry also mentioned where the funds are coming from – the Clubs or the Region? It is up to the Treasurer how to identify it on the books. Everyone needs to give feedback on the Rule change. Bill said if tabled, then it will just be wasted time. If tabled, then a more exact form can be presented and voted on at the May 2023 meeting. Mike C. thinks it's a great idea, but also needs clarification.

Dave Brennan made a motion to table 2023-001 for further discussion at the May 2023, seconded by Chuck Stephens. <u>All Governors voted in favor of tabling for further clarification</u>.

Regional Executive Report (Terry Muich) -

Keeping all of our members in your thoughts – health issues take precedence over everything. At the Governors' meeting suspended reading the members who passed. George Kimble usually reads a poem and George's wife is also ill. Our thoughts and prayers are with George and his wife.

At NCCC Meeting, the newly elected Treasurer resigned. The E-Board appointed Tammy DeWitt to be Treasurer and the committees were reaffirmed.

A Standing Rule Change was presented that if a Rule is changed (*e.g.* 7.9) then every place it is in the Rulebook it will be changed at the same time. This was tabled until the May 2023 meeting. Also there were 3 Bylaws change proposals with the committee for review prior to presentation. Walt Jenkins sent out an email with link to the Rulebook change or can be found on Members Only NCCC website.

There are over 17,000 members and 233 clubs in NCCC. All membership cards have been mailed. Let Club Governor know if not received. The high speed license is not on the hard card – just on the printed card. Dan G. should be contacted about high speed license. If you want to check for high speed licenses, Governors can check on the database for individual licenses. Peg Q. asked if a Governor could print the card for a member – she will work with Barb K. to get access to Peg. Any questions should go to Dan G.

Convention is in Bowling Green, Kentucky with over 600 attendees registrations. The tours are mostly

fully booked. They were surprised at how many rooms are at the host hotel – continuously added to the block of rooms.

New insurance for certificates of insurance (COI). Legacy is still NCCC broker (Tim D.) Philadelphia is another carrier and K&K (owned by Aon). Peg Q. stated that the waiver has been changed – be sure to use the new waiver. With the new carriers, all waivers must be filled out properly – no signing for someone else. Also, flyers must have a statement "**Non-NCCC members are not covered by NCCC Insurance**." Insurance is only a liability insurance – not personal damage. Mike C. asked about the statement on the proper NCCC website flyer – if a non-sanctioned event, a social, there is liability insurance if publicly posted. Contact Allen Morris, Business Manager for NCCC, with questions. Track X 5 – NCM requires liability insurance, but EOR is opening it to all cars. Also, NCCC does not allow electric vehicles. NCM allows electric vehicles. Terry questioned about a rider being available. Jeff Kubiak is running with SCCC and partnering with sanctioned events. If running with SCCC, you have to be a member (for a day is permitted) for coverage under SCCC liability insurance.

NCCC gave over \$14,000 to St. Jude – Buckeye gave \$500, EOR gave \$1,000 and EOR gave \$1,000 to the scholarship.

Next NCCC Meeting is May 6, 2023.

Old Business - Flyers for Track X 5 are available – partnering with Tim Lally. Discount is available by sending Sue H. a check if signed up prior to April 22, 2023. Terry gave out flyers at the NCCC meeting and there seems to be a lot of interest. Contract is in the works – no invoice has been received yet. Corner workers will be about \$5,000, with a total of \$7,000 for corner workers and insurance. Ken G. will be the timer. Tim Lally will bring instructors down and will give improvement information for those involved.

New Business - None

Cheryl G. mentioned that all addresses must have the last four digits after the zip code. NCCC has requested. Governors should go into the database and check their membership.

Genene Patrick has NCCC 2023 pins and shirts for Convention for sale.


