The meeting was called to order at 11:00 am by Regional Executive Terry Muich. The meeting opened with the Pledge of Allegiance led by Chuck Stephens

A quorum is present – 12 Governors.

The 2023 Board was introduced, together with Governors and Guests.

<u>Secretary (Karen Santagata)</u> – Minutes of the March 4, 2023 meeting were emailed to all Governors prior to the meeting. No corrections were made. Chuck Stephens made a motion to suspend the reading of the minutes and to accept the Minutes as emailed, motion seconded by Sharon Burk. Motion passed.

101 FCOA regional members – Reminder to not give out names/addresses of FCOA members. 5 FCOA members turned 16 and therefore may become MAL if Club's age restrictions is 18.

Membership Cards are being worked on – the printer runs only full batches. Governors can print paper copy. When entering members, Cheryl reminded Governors that she needs a NCCC membership form for all new members after Governors is sure the person was never a member. The printer controls the printing due to the cost. If someone loses the original card, the Governor should print a new card – no replacements are sent.

If a member is withdrawing from a Club, all information should be in writing to Cheryl. Cheryl should also receive written information for all MAL member changes.

Cheryl is always available to answer questions – call or email and she will get back to you.

Dave Brennan made a motion to approve the RMD's report, Chuck Stephens seconded it. Motion passed

<u>Regional Competition Director (Dan Gallagher)</u> – Prior to this meeting, Dan emailed his report which is attached to this report and reviewed some highlights so that the Governors who do not attend the NCCC meeting are made aware of what was discussed.

2023 EOR events on website and/or NCCC Competition

RCD Meeting in St. Louis (May 5, 2023)

- Waiver must be signed by all attendees in person
 - Trouble signing waiver go online on NCCC website, print and practice
- Rulebook Electrical vehicles discussion all "Corvette badged" are allowed to participate in NCCC Events. Controversary between GM and NCCC previous NCCC rules no EV's permitted; now NCCC will allow all "Corvette vehicles." Bob Niznick mentioned "hybrid" cars are not fully electric.
- Rule clarification/protest at Progressive Car Show (Corvette Canton) by Corvette Cleveland. RCD took the clarification to NCCC RCD meeting at which time the RCD decided that the clarification was ok. Protest was pending the clarification and it was withdrawn with no penalty to any party.
- Flyer requirement checklist is doing it's job. Dan is a little behind in approving the Flyers; Governors are a little behind nothing is jeopardy of being cancelled.
- Two weekends of events in the books too early to list top 5.
- Suggestion for Governors to attend St. Louis for meeting or review the meeting minutes
- Rule change request that were approved to go further. Governors to vote later
- Bob Niznick SOP that was proposed in Region about voting at car shows is not needed based on the clarification at NCCC. <u>Voting at car shows is up to the host club</u>. Bob's SOP does not need to be in place for EOR as NCCC rule clarification overrules. Terry asked for clarification on the NCCC clarification Dan explained that the host club sets the voting at its sanctioned car shows. Bob's intention was that his proposed standing rule was to clarify the voting. Right now, we are back to where we were 6 months ago when the standing rule was passed. Dan stated that we cannot go against what the NCCC rules are. NCCC cannot stipulate how voting can take place. Bob's standing rule is meant to state what can be done and what cannot be. Terry suggested that a clarification be submitted as to whether it is legal for a region to require all Clubs to follow NCCC rules. Terry and Dan stated that it would be repetitive of the NCCC rules all Clubs must follow NCCC rules. Dan noted that there were a number of Rulebook changes that were discussed and some may only apply to this year depending on further voting/changes. The biggest change might be removed PC Concourse and creating a separate rule for PC Car Shows. Someone (?) clarified that if the region can decide

what the common decision is in the EOR then there will not be any protests going forward.

- Sharon Burk questioned EOR waivers (10/17), NCCC (2009) to which Barb explained that the waivers were not updated. NCCC website has waiver (2009) and with the full insurance waiver language and 12 lines for signatures on every page used. Important things to note line at top of description/location of events/witness signatures and address of witness all must be filled out. Bill Ambuter asked about parental waivers which are the same. Terry explained that the reason for signing waivers was that there was an accident and not NCCC members and then the wife signed on behalf of the husband. The Business Manager has stated that insurance is being difficult and we must abide by their rules. All waivers must be completed in their entirety. Bill Ambuter questioned about vendors signing the waiver even though vendors are not covered. Terry said the waivers can be a proof of attendance and should be signed by all. PERIOD END OF STORY HAVE EVERYONE SIGN THE WAIVER AND FILLED OUT COMPLETELY. Waiver can be printed front and back with the insurance coverage waiver on each page. EOR website will be changed accordingly to include the NCCC waiver. If question, then go to NCCC website. Mike Curtis asked if non-members in attendance need to sign the waiver. Non-members can sign the waiver, but it is not necessary. There is no information on the waiver to locate non-members in case something happens.
- Rulebook changes will be discussed at next NCCC meeting and the put to vote later in the year most likely be electronic.

Bill Ambuter made a motion to accept the Regional Competition Director's report as emailed, seconded by Barb Kukasky. The motion passed.

Finance/Treasurer/Budget Report (Sue Hamilton) – Sue read a thank you notes from St. Jude's and Michelle Cantelmo for the scholarship money. Ray Valentine also thanked everyone for their thoughts, cards and call. Sue sent out the report prior to the meeting and went over the key points. Bill Ambuter raised the question about the money that was in the timing trailer fund. Sue explained about the combination of Competition + timing trailer. The timing trailer shows a negative amount because there is nothing specifically identified as timing trailer expenses – it is contained in the Competition fund. Bob Niznick questioned the cost of gas and the use of the trailer. The Club that uses the trailer pays for the gas to get the trailer to the event and back together with all the supplies used. The timing equipment, insurance and general maintenance is the responsibility of the EOR. TR and Terry worked on the trailer and used "used" product and did not charge the region. Bob also questioned the reimbursement for the cost of the officers to attend the NCCC meeting in May, 2023 – Sue's report ends April 30, 2023. Ray Valentine acknowledged that every volunteer keeps expenses to a limit and some absorb them as their own.

<u>Hall of Fame Committee Report (Mickey Ouellette</u>) – Nominations are open as of today and will close at the September 2023 meeting. Terry does have the hard bond book and will transfer to Mickey The update online book has been updated on the EOR website.

Dave Brennan made a motion to accept the Hall of Fame's report; seconded by Chuck Stephens. It passed.

Questions or suggestions can be presented at any time to the Committees.

Banquet Committee (Sue Hamilton) – Sue thanked everyone who signed up – it's nice to have a banquet again. Breakfast is included for those who are staying at the hotel. A program is planned for the event. No speaker this year – a ventriloquist. Terry thanked Barb and Sue for all their hard work and making the banquet happen this year. Sue thanked Buckeye Corvettes for hosting the banquet and thanked everyone who helped. Terry asked if there was a club that would want to step for next years banquet. This is something that should be done by a club – not the Region. There is nothing in the Rules that states there must be a banquet. Sharon asked why a club has to host it and not the Committee. Terry asked why the committee members need to do all the work. If a club is hosting it, then perhaps that club will have more members in attendance. There is a lot of apathy going on right now – even at the national level. Barb said it could be two clubs. Any changes can be done via a rule change. Sue also thanked the Hall of Fame Committee that agreed to pay for the cakes at the Banquet.

By-Laws and Standing Rules (Terry Muich) -

Bob Niznick made a motion to bring the 2023-001 Standing Rule Change to the floor, Terry Much seconded it. (From March 2023 meeting - Dave Brennan made a motion to table 2023-001 for further discussion at the May 2023, seconded by Chuck Stephens. <u>All Governors voted in favor of tabling for further clarification</u>.)

2023-001 - Standing Rule (Authored by Bill Ambuter)

(Previously presented)

FCOA members are awarded points on regional level. 1 for attendance at sanctioned event 1 for assisting at sanctioned event 1 for NCCC member/sponsor car placing at sanctioned event RCD appoints person to collect points and tabulate Top 5 get award at end of year not to exceed \$150 total Region pays for awards NCCC parent waiver must be signed at registration

Bill Ambuter then discussed what transpired via email and that the frustrating thing was that everyone had an opinion of what should be included. Bill then combined everything and even talked with Shannon Davis. Shannon's informal decision about the standing rule was that FCOA Bylaws do not have an age minimum. He was unsure if the EOR would have to follow FCOA Bylaws. He suggested not to use an age minimum as FCOA does not have an age minimum. Bill stated that this is SOP and can be changed at any time. We need to try it and then if we see issues with it, we can change it. Nothing will be perfect – all have opinions. There is no way we can make everyone happy.

Newly proposed SOP Change

FCOA members will earn regional points

- 1 for attending a sanctioned event
- 1 for helping at a sanctioned event
- 1 for sponsor's car placing at a sanctioned event
- Region will pay for awards not to exceed \$150 per year
- Top 5 members earn awards

Awards given to sponsor's governor at December governors' meeting

RCD will appoint someone every year to collect and tally point

Host club will make sure parent waivers are signed and form fill out properly

Tally form will be made to track FCOA member's points

This rule will promote youths to join FCOA and entice participation at sanctioned events. This allows a FCOA member to learn about NCCC and the Corvette, how to prep for a show, etc. Also provides assistance at events teaching the member what it takes. This will allow growth of the member and in return helps them grow into NCCC members growing the NCCC family in the future to come.

It will allow growth of younger members coming into NCCC in the future keeping NCCC growing for years to come.

We will design a form to track FCOA members with their points earned and a form to track totals thru out the year. Parental waivers already exist thru NCCC.

Bill went on to discuss about a question relating to 1 point per Sanctioned Event and what is actually a Sanctioned Event. Bill suggested that 1 point per Event – not per Sanctioned Event. It's not a competition between Clubs – it is for the kids to make them feel more important and respected at a show. Every FCOA

member does have a sponsor and Bill has a list of the Region FCOA's members which is for Bill's EYES ONLY – not to be shared with the general public. EOR has over 100 FCOA's members. Bill presented the question of 4 or 5 current FCOA that will turn 16 during this current season. Do we allow them to continue to earn points during the season or the day they turn 16 they stop collecting points? Terry suggested the Governors discuss and handwrite in. Chuck Stephens suggested that it goes for the entire competition year no matter if someone turns 16 during the year or not.

<u>Bill then made a motion to adopt the Standing Rule to begin on Sunday, May 21st Car Show.</u> He stated that everything will be ready to go at the Corvette Cleveland event including the parental waivers and the tally form. The RCD will appoint someone to tally the points. Bob Niznick stated it is a good idea and see how it goes. Bill stated that Shannon Davis told him that there are two or three other regions interested in the format. This will promote the membership growth – this rule has increased new FCOA members per Bill. <u>s</u>. Bill stated again that FCOA Bylaws do not have an age limit; however, it is Bill's personal opinion that we will get straggler kids who will get a couple point and that the common age will be 9 - 16 years old. Rallye navigators have to be 9, so they will show up for the points. Chuck Heretta asked if it would be scored by Sanctioned number or by date. Bill stated that it depends on what is decided by the Governors – it could be considered by participation in an event per day or per sanctioned event. Sharon Burk said that the written SOP would need to be changed – Bill said it could just be handwritten. Terry recommended that it stay the way presented – rather than change the wording throughout – per Sanctioned Event. Bill agreed that it will remain as written. Mickey's concern is that the review of the SOP should have gone to the committee for review. It was decided to take a vote on the Standing Rule Change <u>as written</u>.

A hand vote was taken of the Governor's of the Standing Rule. In favor = 5. Against = 3. Abstain = 4. <u>The</u> <u>Standing Rule does not pass – no majority was reached (7 or more)</u>. This Standing Rule can be rewritten and brought up again. Bill said that he is not going to continue pursue.

Banquet Committee - Tim Richisson from Corvette Cleveland made a presentation for the next banquet to be held at Music Box Theatre in the Flats. There is a supper club and then an entertainment venue. This is the best place in Cleveland to have these types of these events. The Region would be responsible for \$1,500 to keep the ticket price per individual to \$40, which would include a pasta bar dinner with various items, with a cash bar. They would dedicate a team of staff for event which would normally cost \$1,800, but it would be included for the evening. An audio-visual package is available for \$400. He would provide any audio-visual equipment if needed. The total projected cost would be 6,146 with 120 attendees ($40 \times 120 = 4,800$). The Wyndham Hotel at W. 150th Street would be designated the hotel, with a possible shuttle to the Music Box. Ouestions included parking at the venue which has it's own parking lot – if no other event going, parking would not be an issue. There is also a \$5 parking lot close by. The question was presented if we do normally get 120. Terry mentioned that this was presented out of sequence and per the Bylaws the proposal should have been presented at the December meeting. Terry asked Tim to provide the information to the Banquet Advisory Committee and then they will review it and visit the venue. One concern is that the dinner venue is 15 minutes away from the hotel. Sue H. mentioned that the banquet fund is only \$1,000 and a discussion which included what happened in the past. She went into some details (50/50 HOF, basket raffle, etc.) to provide Tim with information. A vote will need to be taken at a later date by the Governor's after the Committee reviews it. THANK YOU, TIM, FOR THE PRESENTATION. We appreciate you stepping up!!

<u>Fall Pot Luck – September 30, 2023 – The Amish Door</u> – Flyer is available. The September 2023 Governors' meeting will be there on Saturday morning. Buckeye Corvette Club is also selling raffle tickets for a \$100 gift card to The Amish Door. The winner will be drawn at The Amish Door car show on 8/19/2023.

Regional Executive Report (Terry Muich) -

There will be 12 scholarships announced at the Convention in Bowling Green. A discussion of the gold rings was had and the fact that the fund was \$4,000 short and the funds will be transferred for 2023 winners. There are 746 registered for conventions. A proposal will be made to pay for outgoing officers to attend an additional meeting to assist with transition. There was no Treasurer's Report given at the national report as the

new Treasurer did not have time to accumulate everything.

Jeff Kubick formed a new Club in the Western Oho Region – Fire & Ice.

A Standing Rule Change was passed unanimously – SR2023-01 relating to the changes to the Competition Rulebook. The Change is posted on the NCCC website <u>Competition Committee Approved Rule Changes</u> (Redline) and Clarifications (corvettesnccc.org).

Old Business

Track X 5 is set for June 22 and 23, 2023 and will be lead/follow and transponders will be available. Liability insurance is through the Track for non-NCCC members.

Nominations for EOR Officers open today and closed on 9/8/2023. The vote will be taken at the September 30th Governors' meeting.

Region Executive - Bob N. nominated John Baron. John declined. Region Executive – Barb K. asked if nominated would Terry accept. He declined at this time.

Treasurer – Bob N. nominated Sue. Sue accepted (with the hopes that someone else will be nominated)

Peggy Quine mentioned that if the Region Executive position is vacated, then the RCD would make the appointment.

Terry reviewed the remaining meeting dates for 2023 – Hopocan Gardens is not available for 9/30/2023. The next meeting will be at The Amish Door at 9:30 a.m. The December meeting will be the 9th of December, 2023.

New Business – None

Bob N. asked why EOR does not have a report in Blue Bars. Al Flanhofer had agreed to write an article but has not done so as he is not Governor any longer. (Food was being delivered while a discussion was happening – inaudible on tape.)

There was a break for lunch.

Dan G (Mid-Ohio) – Patches for Team 200 Club were previously passed out. John Baron accepted on behalf of Corvette Cleveland. East Ohio Region had the largest stack of patched at national RCD meetings due to participation by all members. Here's to a successful 2023 Competition season. Timing trailer inventory will be handled by Sharon, Karen and Dan in order to be ready for autocrosses for the year.
